EIF SCHOLARS PROGRAM the year-long enrichment program for first-generation college students culminates in an annual event, An Evening with the Stars, in which scholarships are awarded to these high performing students who are at the top of their class and enrolled in course work which will prepare them for college, such as Advanced Placement courses. This micro-program within the high-school program maximizes the impact with specialized support with their college and career goals for 189 students from 20 schools. The program challenges students to apply to the country's most competitive and comprehensive universities through enriching leadership skills, community service, and student development. In the 2017-2018 school year, participants had a college acceptance of 98%.
